# Who can participate?

Integration courses are subsidised by the Federal Office for Migration and Refugees (BAMF).

**Participation is only possible with an authorisation to participate.**

Depending on your personal situation, you will receive your eligibility to participate from the Foreigners' Registration Office, the Federal Office for Migration and Refugees (BAMF) or your job centre.

## Eligible persons

- Migrants who have received a residence permit for the first time, are living in Germany permanently and have a mandatory authorisation to participate from the foreigners authority
- Persons who have been obliged to participate by the job centre
- Migrants who have been living in Germany for some time and EU citizens as well as German nationals who have received authorisation to participate from the Federal Office for Migration and Refugees (BAMF) upon application
- Tolerated persons pursuant to Section 60a (2) sentence 3 AufenthG
- Persons with a residence permit pursuant to Section 24 AufenthG or Section 25 (5) AufenthG who are admitted to an integration course by the Federal Office for Migration and Refugees upon application
- Late repatriates

If you are unsure whether you are eligible to take part in one of our integration courses, please contact us. We will be happy to help you.

# Content, procedure, organisational matters

The integration courses last three to ten months. They take place from Monday to Friday at different times of the day. Current dates and times can be found on the back page under "Fast Facts".

## Content focus

- Language integration of migrants up to language level B1 (qualification: DTZ certificate)
- Empowerment for social participation and equal opportunities
- Strengthening language and action skills in everyday life and in other subject areas

Raising awareness of the values enshrined in the Basic Law (orientation course module)

## Completion

All integration courses end with a final German test for immigrants (DTZ) and the "Living in Germany" test (LiD). You will also receive an official certificate for participation from the Federal Office for Migration and Refugees (BAMF).

## Costs

Participation is always free of charge if you receive citizen's allowance (Bürgergeld), subsistence assistance, benefits under the AsylbLG or other social benefits.

With our help, you then submit an application for cost exemption to the Federal Office for Migration and Refugees (BAMF). Please bring a current proof of benefit receipt from the job centre or social welfare office. Important: The cost exemption is only granted from the course section following the application, never retroactively.

Without cost exemption, you will pay 229 euros per module or for the entire 100-hour orientation course. The final German Test for Immigrants (DTZ) is free of charge for participants who are authorised to take it; fees may be charged for retakes.

## Registration

Binding registration is only possible in person at our premises. The following documents are always required:

- Authorisation to participate (issued by the job centre, the foreigners authority, the Federal Office for Migration and Refugees or the Federal Office of Administration)
- a copy of your current residence permit (residence card or passport) or your identity card
- if necessary, the corresponding benefit notification so that you can apply for a cost exemption and a travel allowance (from 3 km)

**Important:** If you would like to take part in an integration course subsidised by the Federal Office for Migration and Refugees (BAMF), you must take a placement test before enrolment.
